You and a parent whose information was reported on the SA must complete and sign this institutional verification document, attach any required ments, and submit the form and other required documents to us. ncor DRT s ne	ructions: Complete this section if the student and spouse <u>filed or will file</u> a 2015 IRS me tax return(s). The best way to verify income is by using the IRS Data Retrieval Tool (IRS) that is part of FAFSA on the Web at <u>FAFSA.gov</u> . In most cases, no further documentation eded to verify 2015 income information that was transferred into the student's FAFSA using RS DRT if that information was not changed.
Check the box that applies:	
	The student <u>has used</u> the IRS DRT in <i>FAFSA on the Web</i> to transfer 2015 IRS income tax return information into the student's FAFSA. The verification process will not be able to be completed until the financial aid office receives the updated FAFSA.
	The student is <u>unable or chooses not to use</u> the IRS DRT in <i>FAFSA on the Web</i> , and instead will provide the school a 2015 IRS Tax Return Transcript(s) . The verification process will not be able to be completed until the financial aid office receives the tax transcript.
	To obtain a 2015 IRS Tax Return Transcript , go to www.IRS.gov and click on the "Order a Return or Account Transcript" link. Make sure to request the " IRS Tax Return Transcript " and not the "IRS Tax Account Transcript." Use the Social Security Number (or the IRS individual taxpayer identification number) and the date of birth of the first person listed on the 2015 IRS income tax return, and the address on file with the IRS (normally this will be the address used on the 2015 IRS income tax return). If you prefer you may submit a paper IRS form 4506-T.
	If the student and spouse filed separate 2015 IRS income tax returns, 2015 IRS Tax Return Transcripts must be provided for both.
